# **Privacy Policy**

This Privacy Policy describes how Xtreme Print by Design (the "Website") collects, uses, and shares personal information of users of our website.

#### 1. Information We Collect

We may collect the following types of personal information:

## Information You Provide Directly:

- **Contact Information:** Such as your name, email address, phone number, and mailing address when you contact us, subscribe to our newsletter, or create an account.

- **Device Information:** Information about your device, including device type, unique device identifiers, and mobile network information.

#### 2. How We Use Your Information

We may use your personal information for the following purposes:

- To provide, operate, and maintain our website.
- To personalize your experience on the Website.
- To communicate with you, including responding to your inquiries and providing customer support.
- To send you newsletters, marketing communications, and other information about our products or services (where permitted by law). You can opt-out of receiving these communications at any time.
